Perfect for individuals and groups just getting involved.

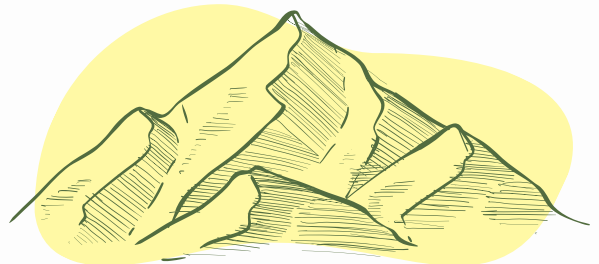
Spread the Word: Share facts and updates on social media, newsletters, or community boards.

Advisory Role: Review and refine the amendment's draft language to ensure strong legal grounding and clear messaging.

Allied Partners: Connect with organizations that are likely to support the amendment to share resources and amplify messaging.

Provide Multilingual Support: Translate educational materials into Spanish or the prevalent language in your community.
